Subject: Petition of MSEDCL for Extension of deadline of 5.1.2011 for Procurement of Power through MoU Route.
- **Case No 64 of 2011**

Maharashtra State Electricity Distribution Co Ltd. (MSEDCL) has submitted a Petition under affidavit on 06/04/2011, under Sections 86(1) (k) and 86 (4) of the Electricity Act (EA), 2003, with the following main prayers:-

“

- a) *Approve the MoU based power procurement for future projects of MSPGCL and NTPC and Extend the deadline of 5.1.2011 for Power Purchase through MoU route with MSPGCL for a period of another 3 years till the time situation improves for introduction of compensation in State of Maharashtra.*
- b) *NPCIL being a CPSU whose tariff will be determined by CEA, the Hon'ble Commission may kindly approve the power procurement through MoU route from NPCIL.*
- c) *Condone any inadvertent omission/ errors/ shortcoming and permit MSEDCL to add/change/ modify/ alter this filing and make further submissions Giver liberty to MSEDCL to add/change/modify/alter this Petition and make further submissions as may be required at a future date”*
