Subject: Petition of M/s Ladam Finance Ltd for non-compliance of the Electricity Ombudsman Order dated 4.11.2011 in Representation No.121 of 2011.
- **Case No. 176 of 2011**

M/s Ladam Finance Ltd has submitted the Petition under affidavit on Commission on 07/12/2011, under Section 142 of the Electricity Act (EA), 2003, against MSEDCL for non-compliance of the Electricity Ombudsman, Mumbai Order dated 04.11.2011, Representation No. 121 of 2011. The main prayers of the Petitioner are as under -

- “A. It is therefore prayed that this Petition, may kindly be allowed under Section 142 of the E.A. 2003 and Respondent be directed to strict compliance of Order dated 04.11.2011 passed by Electricity Ombudsman in Representation No.121 of 2011.*
- B. The Respondent be directed to pay Rs. 100/- per day fine amount from 04.12.2011 to till compliance of Order or (Quantum of fine amount which Hon’ble Commission may deem fit) for non-compliance of Order dated 04.11.2011 passed by Electricity Ombudsman in Representation No. 121 of 2011.*
