**Subject:** Petition of M/s Yash Agro Energy Ltd for adjudication of the claim arising out of denial of Open Access referred by a generating company directly connected to the distribution system of the Distribution Licensee.

**Case No. 24 of 2010**

M/s Yash Agro Energy Ltd. have submitted a Petition under affidavit on 22.06.2010 under Sections 86 (1) (b) (c), (e), (f) and 2(47), R/w 42 of the EA, 2003, for adjudication of the claim arising out of denial of Open Access referred by a generating company directly connected to the distribution system of the Distribution Licensee. The following are the main prayers of the Petitioners:

- a) *Adjudicate on the claims of the Petitioner and pass an order awarding compensation of Rs.60,215,775/- in favor of the Petitioner for the loss suffered by the Petitioner;*
- b) *Pass an order awarding interest @15% p.a. on the amount of Rs.60,215,775/- from the date when such amounts became due and payable on account of loss caused to the Petitioner till the date of filling of the present Petitioner;*
- c) *Pass an order awarding penden-lite interest and also future interest @15% p.a. till the date of actual payment by the respondent;*
- d) *Pass an order directing the Respondent to pay to the Petitioner the costs of the present proceedings before the Hon'ble Commission.*
