Subject: Complaint of M/s Kaygaon Paper Mills Ltd. Under Section 142 read with Section 62(6) of Electricity Act 2003 for non-compliance of the CGRF Aurangabad Order dated 6.10.2010

M/s Kaygaon Paper Mill Ltd has submitted a Petition dated 14/01/2011 under affidavit before the Commission on 09/02/2011 under Section 142 read with Section 62(6) of the Electricity Act (EA), 2003, for non compliance of the CGRF Order dated 06/10/2010 of Aurangabad in Case No.CGRF/AZ/AUR/R/296/2010/23. The following are the prayers of the Petitioner:-

- a. *The Respondent be directed to refund the amount Rs. 225591/- through energy bill as per order passed by Hon'ble CGRF Aurangabad;*
- b. *The Respondent be further directed to pay interest, by way of damages @ 18% p. a on this excess amount from procurement of material date till complete refund ;*
- c. *Any other just equitable relief be granted for the effective adjudication of the subject matter involved in this petition and for its implementation.*
