Subject: Petition of BEST Undertaking for deferment of the implementation of the MERC (MYT) Regulations, 2011.
- **Case No. 43 of 2011**

BEST Undertaking has submitted a Petition under affidavit on 24th March, 2011 under Section 94 (2) of E.A, 2003 and Regulations 85 (A) of the MERC (Conduct of Business) Regulation, 2004, Regulation 4.1, 99 and 100 of the MERC (MYT) Regulations 2011 for deferment of the implementation of MYT Regulations 2011. The following are the prayers of the Petitioner:-

- a) *Admit Petition in accordance with Section 94 (2) of Electricity Act 2003, Regulation 85 (a) of the MERC :(Conduct of Business) Regulation, 2004, Regulations 4.1, 99 and 100 of the MERC (MYT Regulations) 2011.*
- b) *Vary, alter, modify or amend the relevant Regulations under MERC (MYT) Regulations, 2011 on that basis of the submissions ;made by the BEST Undertaking and by taking into consideration our concerns pertaining to power purchase cost, O & M expenses including employee expenses, distribution loss, absence of annual review and other relevant matters already submitted to this Hon'ble Commission.*
- c) *Defer the implementation of MERC MYT Regulations, 2011 for a minimum period of one year so as to enable BEST Undertaking to submit specific Multi Year Tariff based on the approved business plan.*
- d) *Grant liberty to BEST Undertaking to add/change/modify/alter this petition and make further submissions as may be required at a future date.”*
