PUBLIC NOTICE

SUGGESTIONS/COMMENTS ON PETITION FILED BY MSEDCL FOR DETERMINATION OF ADDITIONAL COST AS RELIABILITY CHARGE FOR WITHDRAWAL OF LOAD SHEDDING IN THE THANE –II URBAN REGION INCLUDING KALWA SUB-DIVISION

CASE NO. 89 OF 2009

1. The Commission has approved the Reliability Charge of 28 Paise/Unit for Thane Urban Circle excluding Kalwa Sub-division in Case No. 31 of 2009 dated November 30, 2009 for withdrawal of load shedding from December 1, 2009 to November 30, 2010. MSEDCL has restructured Thane – II Division comprising of Kalwa sub-division.
2. Maharashtra State Electricity Distribution Company Limited (MSEDCL) have submitted Petition dated December 24, 2009 under Sections 62(3), 62(4), 86(1) (b) and 94(2) of the Electricity Act, 2003 for determination of additional cost as Reliability Charge for withdrawal of load shedding in the Thane –II Urban Region including Kalwa sub-division.
3. The present proposal is for inclusion of Kalwa Sub Division under withdrawal of load shedding scheme. The revised Reliability Charge for Thane Region including Kalwa Sub Division works out to 41 Paise/Unit as compared to the earlier approved figure of 28 Paise/Unit.
4. The Commission has admitted the Petition for further hearing, and has directed MSEDCL to invite comments/suggestions from the public on the above Petition through this Notice.
