### SUGGESTIONS/COMMENTS ON PETITION FILED BY MSEDCL FOR DETERMINATION OF ADDITIONAL COST AS ADDITIONAL SUPPLY CHARGE FOR WITHDRAWAL OF LOAD SHEDDING IN THE HEADQUARTERS OF REVENUE DIVISIONS OF MSEDCL LICENSE AREA

#### CASE NO. 31 OF 2009

Maharashtra State Electricity Distribution Company Limited (MSEDCL) have submitted Petition dated July 27, 2009 under Sections 62(3), 62(4), 86(1) (b) and 94(2) of the Electricity Act, 2003, and under Clause 8.2.1 of the Tariff Policy for determination of additional cost as Additional Supply Charge for withdrawal of load shedding in the headquarters of Revenue Divisions of MSEDCL license area, viz., Amravati, Nagpur, Aurangabad, Nasik, Pune, Thane and Vashi.
