Bhandardara Hydro Power Project-II (34 MW)

The Dodson-Lindblom Hydro Power Private Limited (DLHPL) has filed an application on affidavit before the Maharashtra Electricity Regulatory Commission (MERC), for re-determination of tariff for supply of electricity from Bhandardara Hydro Power Project-II (34 MW) to Maharashtra State Electricity Distribution Company Ltd. (MSEDCL), pursuant to the judgment dated December 23, 2009, delivered by the Appellate Tribunal for Electricity. The Commission has taken the above application on record and has directed DLHPL to publish a Public Notice under Section 64 (2) of the Electricity Act, 2003 for inviting suggestions and objections from the Public through this Notice.

Every person who intends to file suggestions and objections can submit the same in English or in Marathi, in six copies, and should mention the full name, postal address and e-mail address, if any, of the sender, by **March 9, 2010**. It should be indicated whether the objection is being filed on behalf of any organization or category of consumers. It should also be mentioned if the sender wants to be heard in person, in which case opportunity would be given by the Commission at the Public Hearing to be held at **the office of the Commission, 13<sup>th</sup> Floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005** on **Monday March 22, 2010** at **11.00 hours**, for which no separate notice will be given.

DLHPL shall reply to each of the suggestions and objections received within three days of the receipt of the same but not later than **March 12, 2010** for all the suggestions and objections received till **March 16, 2010**. The stakeholders can submit their rejoinders on replies provided by DLHPL either during the public hearing or latest by, **March 18, 2010**.
