### **REGULATORY OFFICERS (TECHNICAL)**

The Maharashtra Electricity Regulatory Commission (MERC) has been constituted under the Electricity Act (“EA”), 2003. The role and functions of the Commission have been elaborated in the said Act. The functions of the Commission are quasi judicial, quasi legislative and executive. A copy of the Electricity Act, 2003, Regulations notified by the Commission, Order released so far by the Commission and other related information is available on the Commission’s website [www.mercindia.org.in](http://www.mercindia.org.in).

For discharging its functions the Commission carries out work/activities related to Legal/Technical/Finance tasks. The Commission intends to appoint “Regulatory Officers (Technical)” for the office of the Commission.

Work Responsibilities for Regulatory Officer (Technical):

To assist the Commission on the following Technical matters;

- Evaluation and approval of Annual Revenue Requirement (ARR)/Annual Performance Review (APR) and Determination of Electricity Tariff/Multi Year Tariff of Distribution Licensees, Transmission Licensee and Generating Company applicable to the electricity consumers.
- Vetting of Fuel Adjustment Charges (FAC) and examining the capital expenditure (CAPEX) proposals of distribution and transmission licensees.
- Proposal regarding procurement/purchase of power by Distribution Licensee.
- Determination of Tariff for Renewable Sources of Energy.
- Promotion of Co-generation and generation of electricity from Renewable Energy Source.
- Load Shedding Protocol.
- Demand Side Management (DSM)
- Demand Forecasting.

The methodology for carrying out the above tasks would inter alia include examination of the proposals received from the Distribution/Transmission Licensees. Generating Companies, Generator of Renewable Energy and to make suggestions/recommendations to the Commission in the matter. The work assigned to the Regulatory Officers (Technical) will be required to be done by them independently under the guidance of experienced officers / consultants of the Commission.

### Qualification & Experience:

The Candidate must have degree in Engineering (B.E./B.Tech./M.E./M.Tech. in Electrical/MBA, Graduates in Economics) with minimum 60% marks having 3 years experience in Power Sector companies.

General Conditions: The Candidate should have –

- Excellent abilities in both spoken and written skills in English.
- People with outstanding abilities and a flair for writing will be preferred, Good writing abilities in Marathi will be added qualification.
- Cleared TOFEL/IELTS exam in the past One year will be preferred. (In case the candidate have not appeared/cleared, it should be cleared within nine months from the date of appointment.)
- Computer literacy is essential.
