MSEDCL AND LANCO ENERGY PRIVATE LIMITED**

**CASE NO. 40 OF 2007**

1. MSEDCL filed a Petition on August 30, 2006 for approval of Long Term Power Purchase Agreement (PPA) executed with M/s. Lanco Energy Private Limited (LEPL) for purchasing saleable energy from 500 MW Teesta VI Hydro Electricity Project to be developed in the State of Sikkim. (Case No. 27 of 2006). The Commission issued its Order on approval of long term PPA executed by MSEDCL with LEPL on June 26, 2007.
2. MSEDCL filed a Review Petition seeking review of the Order passed by the Commission in Case No. 27 of 2006. The Commission vide its Order dated February 12, 2008 in Case No. 40 of 2007 has admitted the Review Petition filed by MSEDCL, and has directed MSEDCL to invite comments/suggestions from the public on the above Petition through this Notice.

6. MSEDCL shall reply to each of the objections/suggestions/comments received within 3 (three) days of the receipt of the same but not later than **March 11, 2008** for all the objections and comments/suggestions received till **March 6, 2008**.
