**OBJECTIONS/COMMENTS ON PETITION FILED BY MSEDCL FOR SEEKING APPROVAL OF APPOINTMENT OF THE TATA POWER COMPANY LIMITED AS ADDITIONAL SUPPLY AGENCY, APPROVAL AND REGULARISATION OF POWER PURCHASE FROM THEM FOR THE PERIOD FROM APRIL 4, 2008 UPTO JUNE 30, 2008, AND APPROVAL OF RELIABILITY CHARGES TO BE RECOVERED FROM PUNE CONSUMERS**

### CASE NO. 5 OF 2008

The Maharashtra State Electricity Distribution Company Limited (MSEDCL) has filed a Petition for seeking approval of appointment of The Tata Power Company Limited (TPC) as Additional Supply Agency, approval and regularisation of power purchase from them for the period from April 4, 2008 upto June 30, 2008, and approval of Reliability Charges to be recovered from Pune consumers.

2. The Commission has admitted the Petition for further hearing, and has directed MSEDCL to invite objections/comments from the public on the above Petition through this Notice.

Every person who intends to file objection and or comments can submit the same in English or in Marathi, in four copies, and should carry the full name, postal address and e-mail address, if any, of the sender. It should be indicated whether the objection is being filed on behalf of any organization of category of consumers. It should also be mentioned if the sender wants to be heard in person, in which case opportunity would be given by the Commission at the Public Hearing to be held at **Meeting Hall, Office of the Divisional Commissioner, Pune, on April 25, 2008 at 10.00 hours**, for which no separate notice will be given.

6. MSEDCL shall reply to each of the objections/comments received within 3 (three) days of the receipt of the same.
