The Maharashtra State Electricity Distribution Company Limited (MSEDCL) has filed a Petition for approval of deviations taken in RFP project documents from Standard Bidding Document issued by MoP for competitive bidding process for Dhopave Project under Case-II bidding before Maharashtra Electricity Regulatory Commission. The Commission has admitted the Petition on August 1, 2008 (Case No. 33 of 2008) and has directed MSEDCL to publish a Public Notice for inviting objections, comments and suggestions on the Petition.
