SUGGESTIONS/COMMENTS ON PETITION FILED BY MSEDCL FOR SEEKING IN-PRINCIPLE APPROVAL FOR APPOINTMENT OF ADDITIONAL SUPPLY AGENCY FOR VASHI CIRCLE- NAVI MUMBAI AND THANE URBAN CIRCLE FOR PERIOD MAY 2008 TO JUNE 2008 AND OCTOBER 2008 TO JUNE 2009, AND APPROVAL OF RELIABILITY CHARGE TO BE RECOVERED FROM CONSUMERS OF THESE REGIONS.

CASE NO. 10 OF 2008

The Maharashtra State Electricity Distribution Company Limited (MSEDCL) has filed a Petition for seeking in-principle approval for appointment of Additional Supply Agency for Vashi Circle- Navi Mumbai (Vashi, Nerul, Panvel) and Thane Urban Circle (Bhandup, Thane, Mulund, Wagle Estate, Kalwa (excluding Mumbra and Kalwa sub-division)) for the period May 2008 to June 2008 and October 2008 to June 2009, and approval of Reliability Charge to be recovered from consumers of these regions.

2. The Commission has admitted the Petition for further hearing, and has directed MSEDCL to invite comments/suggestions from the public on the above Petition through this Notice.

It should also be mentioned if the sender wants to be heard in person, in which case opportunity would be given by the Commission at the Public Hearing to be held at **Centrum Hall, 1st Floor, World Trade Centre, Centre 1, Cuffe Parade, Mumbai 400 005, on May 2, 2008 at 11.00 hours**, for which no separate notice will be given.

6. MSEDCL shall reply to each of the suggestions/comments received within 3 (three) days of the receipt of the same.
